Ciatti has a long standing relationship with the Indelicato family and was instrumental in creating a win-win situation for both families. Black Stallion Winery is located in the Oak Knoll District of Napa Valley, three miles north of the town of Napa along the famed Silverado Trail. The winery takes its name from an equestrian facility, the Silverado Horseman's Center, which was located on the grounds many years ago. The original property featured riding trails, stables and an outdoor arena where Francis Ford Coppola filmed the helicopter scene from Apocalypse Now. Today the Black Stallion Winery includes estate vineyards, an elegant tasting room and hospitality center as well as two guest cottages.
